

Taking Part in a Séance Room EVP Recording

I'm delighted that you're considering taking part in a recording and witnessing first hand, the voices of those who may be around you. This is *your* opportunity to hear virgin EVP, *your* time and *you* get to ask the questions!

It's important before you decide to book, to be fully aware of the conditions required to record and what you can expect to happen during your visit. Please forgive the formality of this bookings notice, but it is necessary to provide you with all the information ahead of time, because I do not want you to be disappointed.

Whilst recording for EVP can be a lot of fun, and it is truly fascinating, I take what I do seriously and expect you to do the same. It is NOT entertainment and should not be considered as such. Recording time should entered into with respect and open curiosity for those who may communicate. You are not required to *believe*.

The venue used for recording:

This booking is for a private recording for up to two people, in our séance room. It is <u>not an invitation to our group séance</u>. Please be aware that I am not a working medium and not unable to provide this service.

Conditions of attendance:

- The building used needs to quiet, no phones or cameras are permitted in the séance room.
- You may bring an audio recording device, any other device is not permitted.
- You will be asked to leave immediately if any device than for audio recording, is brought into the room.
- You are welcome to bring a friend.
- Recordings are done from 8pm to 10pm.
- The use of alcohol/drugs, prior to, or during recording by anyone present will result in cancellation.
- All attendees must be over 21 years of age.

Limitations of recording:

- The maximum length of a recording will be 2 hours. Should environmental conditions deteriorate, the recording will have to stop, as the integrity of the EVP becomes questionable.
- I have absolutely no control over whom we may record, I cannot contact specific individuals.
- I cannot guarantee that you will recognise any voice that is captured.
- It is rare but on occasion, no clear voices will be captured, this is more likely under poor conditions.

Post recording events:

- The recording needs to be transferred to a laptop in real-time.
- If the session was 2 hours, it would be approximately 00.30 hrs before the recording is ready for you to take away.

The digital recording:

- You may be present while the recording uploads, or provided with a copy of the raw recording.
- You will need to provide a minimum 1GB USB stick for your copy of the recording, if you wish to take it with you.
- You may share the recording, but should reference it being an EVP Voices recording.

Review:

- If you wish to return the next day and be present for the full review of the recording, be aware that the process can be lengthy and tiring if you are unaccustomed to concentrating for long periods.
- A 2-hour recording can take 10 hours for a detailed review, you may wish to consider reviewing only a small section of the whole recording whilst we are together that evening, or return the next day.
- If you do not want to be present for the review, I will provide you with isolated clips at a later date, time stamped for cross referencing against the raw recording that you will hold.



Booking Conditions

Cancellations:

There is no charge for a recording session, however, I have a busy life and am not able to accommodate last minute changes to bookings. If I am not notified of your intention to cancel or postpone a booking at least 48 hours in advance, it will not be rearranged.

Privacy:

I will not publish any isolated EVP or the recording, unless you specifically give me permission.

Location:

I am based in the Forest of Dean, Gloucestershire. The address will be provided after your booking is confirmed. A date that is mutually convenient will be agreed during our call. One secure parking space is available.

If you would like to proceed to booking, please ensure you have read through the booking conditions. Your signature is acceptance and understanding of the requirements and limitations of taking part in a recording.

Prior to your booking being accepted, all of those attending the recording session will be required to join me for a 10 minute video call. *This is not optional*. Should you not wish to go ahead after submitting your request, all of your details will be permanently deleted and no record will be retained.
